TEXAS POLYGRAPH EXAMINER'S ACT

As of September 1, 2021, the Texas Legislature did away with the Texas Polygraph Examiner's Act / Occupations Code 1703.

There is no requirement to hold a Polygraph License to administer a Polygraph Examination in the State of Texas. This leaves the public unprotected concerning the qualifications concerning MINIMUM QUALIFICATIONS, EDUCATION, TRAINING AND EXPERIENCE OF ANY POLYGRAPH EXAMINER THEY USE TO ADMINISTER POLYGRAPH EXAMINATIONS.

THE PUBLIC SHOULD REQUEST AND REVIEW THE PROFESSIONAL QUALIFICATIONS, EDUCATION, WHERE A POLYGRAPH EXAMINER RECEIVED THEIR POLYGRAPH TRAINING, IF THEY COMPLETED THEIR TRAINING, INTERNSHIP AND IF THEY WERE EVER LICENSED AS A POLYGRAPH EXAMINER.

The J P C O T Guidelines will remain in effect, minus the License Requirement.
